You must complete the *Apprentice Orientation* for your application to be processed. You should bring the completed application with you to orientation if you have not yet attended.

NOTE: In order to avoid termination of playing privileges from Section, any approved player who leaves a job or is terminated before the end of the season or contract, shall furnish to Section Officers, in writing, an explanation of circumstances.

REQUIREMENTS FOR PLAYING PERMITS

SECTION 1: To be able to compete in tournament activities throughout the Utah Section, a person must be registered in the National Apprentice Program or registered for a PRO and must make application for playing privileges which shall be a form used by the Utah Section PGA of America. All applicants for a players permit must provide a W-2 form from the previous year with their application (or if the application is received during their 1st working year the applicant will be required to provide such papers as the Executive Committee may require to properly verify that the employment is within the guidelines). For purposes of section playing privileges, an apprentice will be defined as working an average of 40 hours per week over a five month period, either as an Assistant Professional or a Non-Member Head Professional.

SECTION 2: Application for player's permits must be presented to and approved by the Executive Committee. The Section Executive Director and one Section Officer must sign the application. (An Apprentice must allow two weeks for the processing of the application).

SECTION 3: *Player Permit fees (\$100.00) will be included with your National Dues billing from the PGA of America. Late applications for a player permit will be accepted upon completion of the Apprentice Orientation. Please do not submit this application until you have attended the orientation.*
